

2.3.1 Overview




Fig. 1: Scope of delivery

2.3.2 Compatible components

The fitting holder is intended for use with two concealed valves or a water meter with a concealed valve.

3.1.1 Installation dimensions





Fig. 2: Installation dimensions



3.2 Assembly

3.2.1 Mounting module




Use the slot nuts supplied to attach the fitting holder to the open mounting rail.

Insert the slot nut into the opening of the module.




Push the slot nut in until it engages.




Set the height of the rail.






Fasten the slot nut.



Set the height of the fitting holder according to the information of the sanitary item manufacturer.

3.2.2 Rounding off jobs



- Clad the pre-wall with suitable gypsum cardboard cladding panels.
 Make sure that no abutting edges converge.
- Grout the abutting edges and joints with a suitable filler.
- For more detailed information, observe the mounting instructions for the gypsum cardboard cladding panels.

3.3 Disposal

Separate the product and packaging materials (e. g. paper, metal, plastic or non-ferrous metals) and dispose of in accordance with valid national legal requirements.
