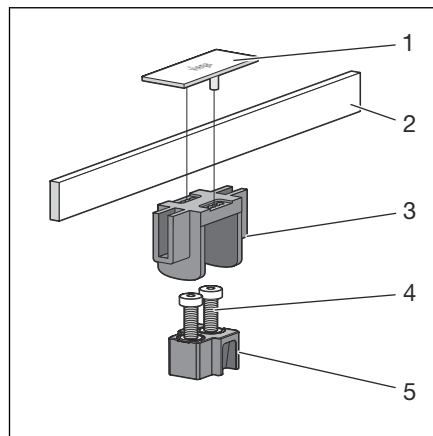
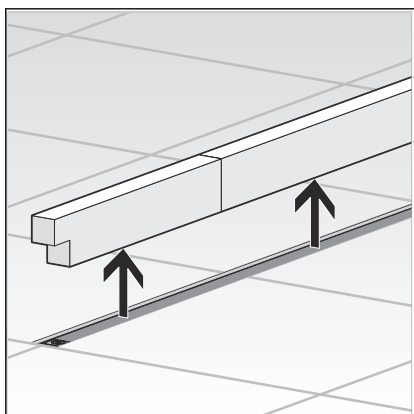


Fig. 1: Scope of delivery

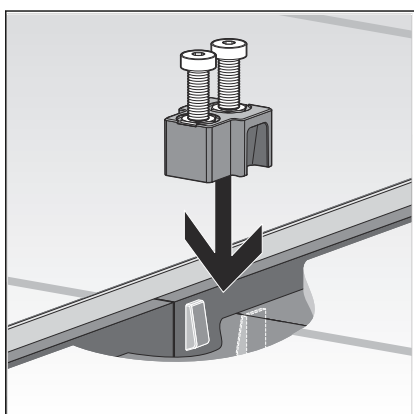
- 1 - cover cap

3 Handling

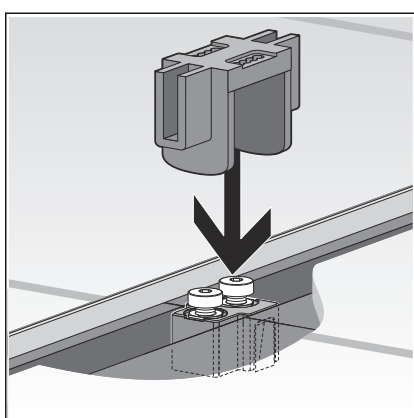
3.1 Assembly



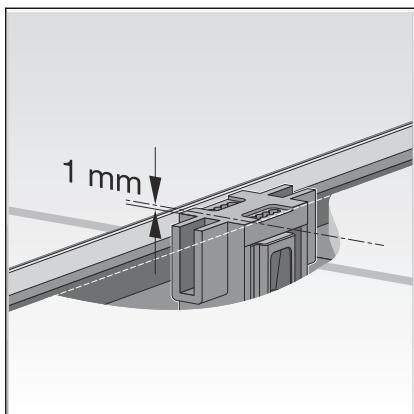
- Remove protective insert.



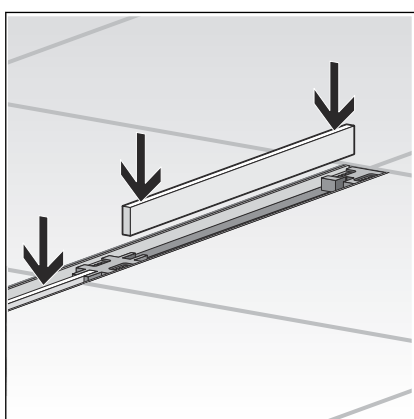
- Insert the connector insert with the screws.



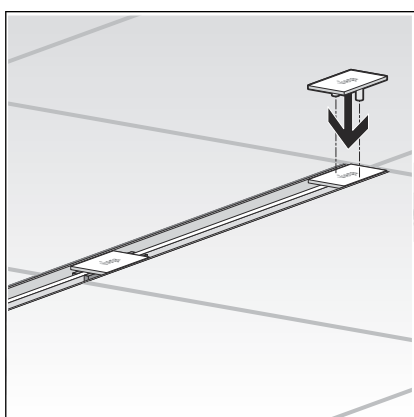
- Place the grate holder onto the screw and adjust to tile height.
The maximum height of the standing grate is 20 mm above the flange.
When using the natural stone set, the maximum height of the standing grate is 30 mm above the flange.



- The upper edge of the grate holder must be approx. 1 mm below the upper edge of the tiles.



- Insert the standing grates.



- Push in the cover cap.
The cover caps can be moved by up to 5.6 mm.

3.2 Disposal

Separate the product and packaging materials (e. g. paper, metal, plastic or non-ferrous metals) and dispose of in accordance with valid national legal requirements.
