



2.1 Areas of application

The odour trap is suitable for washbasins with 1¼ inch connection.

2.2 Product description



- 1 Odour trap
- 2 Drain elbow for 1¼ inch connection with union nut and seal

2.3 Technical data

Drainage capacity	0.6 l/s
DN (nominal width) outlet pipe	DN 32/40 mm
Drain elbow connection	1¼
Water seal level	50 mm




Fig. 1: Dimensional drawing

3.1 Assembly






Fig. 2: Mounting dimensions

Requirements:


- The washbasin is mounted.
- The drain pipeline is installed.




► Insert the odour trap.



► Determine the length X of the drain elbow.
Cut the drain elbow to length and deburr it.



- Coat the drain elbow with the lubricant and insert it.
- Adjust the height of the odour trap.



- Screw the drain elbow to the washbasin.

3.1.2 Leakage test

The leakage test is only carried out as a visual inspection. Check the drain for visible leaks.

3.2 Care and cleaning

Care

Use household cleaner to remove coarse soiling, also around the drain unit and the odour trap. Rinse the detergent thoroughly with clear water after the prescribed exposure time. There should be no residue on the components.

- Normal soap or a mild cleaning agent can be used for regular maintenance and prevention of lime scale.
- Strong stains can be removed using typical household cleaner. Rinse the detergent thoroughly with clear water after the prescribed exposure time.
- Dry the surfaces with a soft cloth. There should be no residue on the components.

3.3 Disposal

Separate the product and packaging materials (e. g. paper, metal, plastic or non-ferrous metals) and dispose of in accordance with valid national legal requirements.
